Overdue balances paid by credit card are subject to a 2% late payment charge.</p> <p>An interest charge of 2% per month (24% per annum) will accrue and be payable on all balances past due.</p>
PRICES	<p>Prices shown are list prices unless otherwise noted. The ALGGIN price list in effect at time of shipping will be used. Prices are subject to change without notice.</p>
QUOTATIONS	<p>All quotations are firm for 30 days. After 30 days, the price is subject to change.</p>
HOLDBACKS	<p>Holdbacks which apply to contracts are not part of terms of credit or quotation and will not be accepted.</p>
FREIGHT	<p>All merchandise F.O.B. ALGGIN. Unless routing is requested, all shipments will be made via routing designated by ALGGIN. All items are guaranteed to be in good condition when they leave our F.O.B. point. From this point the carrier takes full responsibility for the goods.</p>
RETURNED GOODS	<p>ALGGIN STOCKED Products: Returned goods accompanied by the ALGGIN invoice number are subject to a minimum 15% restocking charge. Returned goods without the ALGGIN invoice number are subject to a minimum 25% restocking charge.</p> <p>ALGGIN NON-STOCKED Products: Returned goods are subject to restocking charges as specified by each original equipment manufacturer.</p> <p>No goods are returnable without prior approval. Freight must be prepaid, and any goods installed or damaged will not be accepted for return. Custom manufactured products are NOT returnable.</p>
